[Authorization for operating a facility for generation, collection, reception, treatment, storage, transport and disposal of bio-medical wastes]

1. Number of authorization **223/HO/BMW/CECB/ATAL NAGAR, RAIPUR.**
2. Reference of Online Application No. **4065003 dated 27/09/2019.**
3. The authorization granted vide letter no. **7742/BMW/HO/CECB/2015 Raipur, dated 02/03/2015** to occupier of facility i.e. **Shri Shankracharya Institute of Medical Science (744 Beds), Junwani, Bhilai, Distt.- Durg (C.G.)** is hereby renewed an authorization to operate a facility for generation, collection, reception, storage, transport, treatment and disposal of Bio-Medical wastes as per the agreement proposed with **M/s SMS Watergrace Enviroprotect Pvt. Ltd., P.H.No.-20, Kh. No.-70/(1, 2, 5), Village-Siltara, Dharsiwa, Distt.-Raipur (C.G.)** for disposal of BMW which has been granted authorization by **C.E.C.B. Raipur.**
4. This renewal of authorization shall be in force for period from **06/11/2019** to **01/03/2022.**
5. This renewal of authorization is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act 1986.

TERMS & CONDITIONS OF AUTHORIZATION

1. The authorization shall comply with the provisions of Environment (Protection) Act, 1986 and the rules made there-under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the prescribed authority.
3. The person authorized shall not rent, lend, sell transfer or otherwise transport the Bio-Medical wastes without obtaining prior permission of the prescribed authority.
4. Any unauthorized change in personnel, equipment, or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
5. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
6. The occupier shall submit in annual report in enclosed form-IV by 30th June every year to concern Regional Office of the Board.
7. No untreated Bio-Medical waste & shall be kept stored beyond a period of 48 hours. Provided that if for any reason it becomes necessary to store the waste beyond such period, the authorized person must take permission of prescribed authority and take measures to ensure that the waste does not adversely affect human health and the environment.
